



⁶⁶ Nakilat takes over SHIP MANAGEMENT of first LNG vessels⁹⁹

Nakilat has successfully taken over the management of Al Hamla, Al Gharrafa, Al Gattara and Tembek, making them the first four LNG vessels to be operated by wholly-owned subsidiary NSQL.

H.E. Dr. Mohammed bin Saleh Al-Sada, Minister of Energy and Industry and Chairman of Nakilat, officially initiated the management takeover of the first vessel, Al Hamla, via video conference call from Doha to the ship at the end of May.

Management of the last of the four ships, Tembek, was transferred to Nakilat at the end of July.

Nakilat now manages and operates a total of eight vessels via NSQL — four LNG and four LPG vessels.

⁶⁶ Nakilat increases LNG fleet with THREE NEW VESSELS ⁹⁹

Refinancing worth US \$807.4m with QIB and Barwa Bank has enabled Nakilat to increase its total fleet from 62 to 65 vessels.

The three new LNG vessels have been added to joint venture Maran Nakilat Co. Ltd., which closed US \$807.4m of refinancing provided by Qatar Islamic Bank (QIB) and Barwa Bank.

The refinancing deal was signed in April during a ceremony attended by senior representatives from Nakilat, QIB and Barwa Bank. The contracts were signed by Eng. Abdullah Fadhalah Al Sulaiti, Managing Director of Nakilat; Bassel Gamal, QIB Group CEO; and Khalid Al Subeai, Acting CEO of Barwa Bank.

The three new LNG carriers increase Maran Nakilat Co. Ltd.'s total fleet from eight vessels to 11. The new ships will be used in international trade.

N-KOM AND GDI SIGNING



⁶⁶ N-KOM signs contracts worth US \$110 MILLION with GDI ⁹⁹

N-KOM has signed two contracts with Gulf Drilling International (GDI), the largest oilfield service company in Qatar, worth a total of US \$110 million.

The contracts were signed in the presence of H. E. Dr. Mohammed Bin Saleh Al Sada, the Minister of Energy and Industry and Chairman of Nakilat, at a ceremony in July. Eng. Abdullah Fadhalah Al Sulaiti, Managing Director of Nakilat and Chairman of N-KOM, and Mr. Ibrahim J. Al-Othman, Chief Executive Officer of GDI, signed the contracts.

The first contract is for the construction of a liftboat. The self-propelled and self-elevating structure is customized for operations in the Middle East in water depths of up to 65 meters. Due to be completed at the end of 2015, the liftboat is the first such vessel to be built in Qatar.

The second contract awarded to N-KOM is for six years of repair and maintenance for GDI's existing fleet of jack-up rigs operating in the Middle East.



FINANCIAL RESULTS

•• Nakilat announces net profit GROWTH OF 24% for the first half of 2014 ??

Nakilat announced its financial results for the first half of 2014, including net profit of QR 446 million compared to QR 360 million achieved during first half of last year — an increase of 24%.

In an announcement Nakilat's Board of Directors stated that the strong results of the company's earnings clearly reflect the strength and stability of the company's financial position. The Board added that the prudent and effective strategic plan related to the development of Nakilat's main business activities in the transportation of LNG to include international markets had resulted in an increase in the number of operating vessels in Nakilat's fleet during the first half of 2014.

The Board also underlined the positive effect both of the improvement in the international charter rate for the transportation of LPG and of the increased operating activities at Erhama Bin Jaber Al Jalahma Shipyard, which will continue to underpin Nakilat's future financial results.

The Ministry of Energy and Industry presented Nakilat with the Annual Qatarization Certificate for its achievements in Qatarizing the workforce.

The award, presented in May, was collected from H. E. Dr. Mohammed Bin Saleh Al Sada, Minister of Energy and Industry, by Eng. Abdullah Al Sulaiti, Nakilat's Managing Director, at an award ceremony held at the St. Regis Doha.



N-KOM AND QPMC SIGNING NDSQ DELIVERS BOATS TO NSW QCC VISIT

N-KOM has secured a contract worth QAR 69 million to design and construct a floating jetty for Qatar Primary Materials Company (QPMC). Scheduled for completion in early 2015, the floating jetty is the first project that N-KOM will be undertaking for QPMC.

The floating jetty situated in Ras Laffan Industrial City will be QPMC's second floating jetty in Qatar. Serving as an offloading point for aggregates, the jetty will be in close proximity to the stockpile located within the industrial city. Once complete, the jetty will have an annual aggregates handling capacity of 7.8 million tonnes.

N-KOM has been contracted for the engineering, procurement, installation and construction (EPIC) of the floating jetty.



NDSQ DELIVERS BOATS TO NSW



NDSQ delivers two mooring boats to NSW ??

NDSQ successfully delivered two 16-metre mooring boats to NSW in August. NSW will operate the vessels in the Port of Ras Laffan.

The two mooring boats have been named Ras Al Allaj Qatar and Al Esaiwed. NDSQ is currently building a further five vessels for NSW, also for use at Ras Laffan.

The vessels are part of NSW's growing fleet and will work on a long term charter to QP.


•• Nakilat shipyard hosts visit from QATAR CHAMBER ??
